II. FINDINGS

This matter was tried to a jury between January 26, 2026, and February 13, 2026, with the Honorable Jason Holloway presiding. Plaintiff appeared through her attorneys of record James Beck, Janelle Chase Fazio, and Eric Gilman of Beck Chase Gilman, PLLC. Defendant appeared through its attorneys of record, Brad Bigos and Alex Lopez of O'Hagan Meyer, PLLC, and Michael Barcott of Holmes Weddle Barcott, P.C.

The parties presented evidence and testimony to the jury and on February 13, 2026, the jury returned a verdict in favor of Defendant Coastal Transportation and against Plaintiff Kathleen Frates on all claims. A copy of the signed Verdict Form is attached as Exhibit A.

Defendant Coastal Transportation noted a hearing without argument for entry of this Judgement (SUB# 281). Plaintiff counsel was electronically served with the notice and pleadings (SUB# 282). The court considers the briefing from Defendant, including but not limited to the Presentation and Declaration of Brad Bigos (SUB# 277) and the Cost Bill (SUB# 279). The court finds no responsive or opposition briefing in the court file.

The court reviewed and analyzed the Cost Bill and finds the attorney fees and expenses to be reasonable and appropriate. The court addresses this motion without oral argument.

III. ORDER

THEREFORE is it ORDERED that judgment is entered in favor of Defendant Coastal Transportation and against Plaintiff Kathleen Frates--in the amount of \$623,808.53 detailed as as follows:

2. Global Transportation, Inc. is the prevailing party under RCW 4.84.250 and RCW 4.84.260 and is entitled to reasonable attorneys' fees. Reasonable attorneys' fees in this matter are \$404,684.50, as supported by Defendant's Cost Bill and the court's independent analysis of fees incurred.

3. Global Transportation, Inc. is also entitled to an award of costs in the amount of \$219,124.03.

4. Global Transportation, Inc. is awarded interest on this judgment from the date of this judgment until time of payment at the rate of 12% per annum.

IT IS SO ORDERED.
